## II International Piano Competition on-line Rules of the Competition

1. The organizer of the 2st International Piano Competition Music Phenomena' 2023 is the Pro Juventus Foundation
2. The competition is open to all interested pupils, students and professional musicians in piano.
3. The competition is one-stage and is conducted entirely online.
4. The jury of the competition consists of world-famous concert pianists and eminent

educators: Janusz Olejniczak, Andrzej Jasiński, Jerzy Sterczyński, Justyna Galant - Wojciechowska, Anna Borkowska and Dorota Budejko, President of Pro Juventus Foundation and the Competition Director.

#### Rules for Participation

Young pianists are invited to attend the Competition in the following age categories: Group I – born 2011 and later

Group II – born in years 2008 – 2010 Group III – born in years 2005 – 2007 Group IV – born in years 2002 – 2004  
Group V – born before 2002

The participant has the option of choosing a higher group

## Recording Time:

Group I - up to 10 minutes

Group II – up to 15 minutes

Group III – up to 20 minutes

Group IV, Group V – up to 25 minutes

## Program

- The program for groups I and II is a free program,
- For groups III, IV - the repertoire must include (1) the classical sonata first movement or classical variations and (2) a virtuoso piece (or additional piece / s), and take into account the recording time specified above for each group.
- For group V - the repertoire must include (1) the classical /romantic first movement or variations, or virtuoso part of the 20th-century sonata and (2) a virtuoso piece (or additional piece / s), and take into account the recording time specified above for each group.
- Exceeding the playing time may result in rejection of the candidate.
- The program must be performed from memory.

## Rewarding Rules and Types of Rewards

There will be prizes and distinctions in every groups and the list of Prize winners including prizes will be announced public.

All participants will receive participation diplomas sent to the e-mail address provided in the application. The winners of the 1st place and special prizes will receive a specially prepared Music Phenomena 2023 statuette.

The jury may award the additional prizes:

- for the artistic personality Music Phenomena 2023
- for the best performed piece of Chopin,
- for the best performer popularizing the music of the composer - Maria

Szymanowska

- The jury may decide about awarding prizes in addition to these for groups winners and guaranteed awards.
- The jury reserves the right not to award some of the prizes, to bestow prizes and places ex aequo, as well
- as to decide on sharing places and prizes at their discretion.

- The jury's decisions are final and non-appealable.

### **Application submission rules**

To qualify to the competition the application must be submitted according to the rules by 31.03.2023

- Before completing the application a video recording should be uploaded to YouTube in the unlisted access formula.
- The application should be accompanied by scans of the following documents:
  - a) application form – available to be downloaded at [www.musicphenomena.com](http://www.musicphenomena.com)
  - b) a copy of the document confirming the date of birth
  - c) a short biographical note
  - d) a proof of payment of the entry fee
  - e) a portrait photo with a minimum resolution of 150dpi

### **Fee payments from participants**

Application fee differs between age groups:

1. participants in the I and II group = 50 EUR - or 200 PLN

(early registration till 15.02.2023 40 EUR – or 170 PLN) 2. participants in other groups = 70 EUR – or 300 PLN

(early registration till 15.02.2023 60 EUR - or 250 PLN) 3. The entry fee should be paid to the following account:

- with the transfer title: **Donation (Music Phenomena 2023)** and the **name of the participant**.
- Participants who are under 18 on the day preceding the start of the Competition should attach to the application a declaration by one of their parents / guardians about their consent to candidate's participation in the Competition.
- In the event of resignation from the Competition, the entry fee is not refundable.

## Recordings

The recording must meet the following criteria:

### Dates

- the video should be **one indivisible file** made from a tripod. It cannot bear signs of merging or tampering.
- a recording should be placed on YouTube in a unlisted channel with a provided link
- access to the recording cannot be blocked until the end of the competition - the announcement of the results
- the entire silhouette of the artist must be visible on the recording,
- the title of the recording should include: name and surname, age of the participant (calculated annually)
- the description of the recording is to include the repertoire including: the composer, the title, any numbers, opuses, parts, etc.
- the quality of the recording is subject to verification (HD quality is preferred)

In the case of quality preventing reliable assessment of the participant, the organizers have the right to request a recording with better image or sound quality

1. **The closing date for accepting applications is 31.08.2023.**
2. Applications sent after August 31, 2023 will not be accepted.
3. Announcement of results of the competition will take place by **October 31, 2023.**
4. The list of awarded winners with a detailed description of the awarded prizes will be

### Consents

Participants are required to grant Pro Juventus Foundation free permission to use their artistic performances and dispose of rights to them in the following fields of use:

- recording and reproduction: production by any technique copies of artistic performances, including magnetic and digital recording techniques
- dissemination: broadcasting and rebroadcasting as well as reproduction and public access to recordings of artistic performances in such a way that everyone can have access to them at the place and time of their choice.

Participants entering the Competition agree to the public sharing of the recording by the organizers through their own websites and befriended web services

To conduct the Competition, it is necessary to provide the following personal data:
